RENTER AGREES to pay to CENTSIBLE SOUNDS, 400 McTeer Drive, Kingsport, TN 37663 the TOTAL MONTHLY PAYMENT as stated above for each month, in advance, that the instrument, bow, and/or case are provided by CENTSIBLE SOUNDS for the use of the RENTER. RENTER AGREES to maintain the instrument, bow and case in excellent condition and submit the instrument, etc., to CENTSIBLE SOUNDS for maintenance and repair as needed.

Loss/Damage

The renter will be responsible for our instrument, including theft or damage (reasonable wear excepted), until the instrument is returned. CENTSIBLE SOUNDS accepts the above liability if the renter purchases the optional insurance. Claims for stolen instruments must include a police report. Insurance covers broken bridges, bows, and replacement of broken strings with rental quality

strings. When the rental expires, the insurance expires. Insurance is not in effect during air or overseas travel, except with specific authorization. Insurance will not cover: Theft from motor vehicle, heat damage while in a motor vehicle; lost or intentionally damaged instruments, damage incurred during shipping; or shipping costs. If an uninsured instrument is damaged or stolen, we reserve the right to charge the cost of repair or replacement to any credit card on file. We must perform or authorize all repairs.

Cancellations

RENTER MAY CANCEL this contract at any time, provided that all charges are paid in full, by returning the instrument, bow, and/or case to CENTSIBLE SOUNDS.

Upgrades/Trade In

This is not a Rent to Own+contract. However, if RENTER wishes to purchase an instrument, we will apply 100% of the first year's rental fees to the purchase of the rental instrument at its List Price. 100% of first year rental fees, and 80% of subsequent year rental fees may be applied to the purchase price of a new instrument, provided the maximum credit allowed toward any instrument, case, and bow purchase may not exceed 80% of the purchase price of that instrument, case, and bow. Discount towards purchase must be applied within 30 days of termination of this contract. Discounts are not held for future application.

Exchanges

Exchanges to the next instrument size will be made free of charge assuming rental payments have been made on time and are current, and the previous instrument is returned in good condition, allowing for normal wear and tear.

FIRST PAYMENT is due on or before delivery. SUBSEQUENT PAYMENTS are due monthly on the rental date (i.e. if the instrument was rented on 18th of the month, subsequent rental payments are due on the 18th of each month.) Payments not received within thirty (30) days of the invoice date will be subject to a LATE CHARGE of 1.5% of the amount due or \$2.00, whichever is greater. There will be a \$15.00 handling fee for checks returned to us unpaid for any reason. Rental fees may be paid by check, but instruments will not be rented without a valid credit card on file.

INSTRUMENT, BOW, and CASE are the property of CENTSIBLE SOUNDS. RENTER grants to CENTSIBLE SOUNDS the right to recover the instrument, case, and/or bow at any place, any time, by any legal means, for nonpayment of charges. CENTSIBLE SOUNDS reserves the right to charge the RENTER for the full value of the instrument, case, and/or bow if the account is delinquent 60 days or more. In addition, the RENTER will be liable for reasonable collection and attorney's fees where this contract is referred to a collection agent or attorney who is not a salaried employee of CENTSIBLE SOUNDS, and court costs.
